#### Canada Launches 988 Suicide and Crisis Helpline

988 is now the three-digit number that sends callers to the Suicide and Crisis Helpline.

This is a free texting and calling service, available to all Canadians 24 hours a day, seven days a week. 988 offers trauma-informed and culturally appropriate services from trained crisis responders in both English and French.

Remember, if a patient discloses abuse, self-harm, or suicidal thoughts, it's important to stop your assessment or treatment and address the comments.

## Privacy Reminders -Sharing Personal Health



#### Information

Physiotherapists are responsible for safeguarding all personal health information.

Ontarians have the right to privacy. Patients should understand how their personal health information will be collected, used, and disclosed. Physiotherapists must follow all privacy requirements and get consent to share personal health information.

Advice from the Practice Advisors when it comes to privacy and sharing personal health information:

**Stop**: Sharing personal health information with others without consent or authorization from the patient.

**Start**: During intake, ask the patient what personal health information can be shared and who it can be shared with. Document the patient's consent.

Physiotherapists can assume that they have a person's consent to collect, use or disclose personal health information for the provisions of health care use if the following conditions are met:

- The information was received from the patient (or substitute decision-maker) or another Health Information Custodian (HIC).
- The information is collected, used or disclosed for the purpose of providing health care to the patient.
- The information disclosed will only be shared with another Health Information Custodian (HIC).
- The patient has not withheld or withdrawn consent.

#### New Resource: Policies and Procedures Checklist

Physiotherapists are required to have certain written policies and procedures in place to help manage things like adverse events, fees, and communication with physiotherapist assistants (PTAs).
