#### **NOTICE OF HEARING**

The Inquiries, Complaints and Reports Committee of the College of Physiotherapists of Ontario has referred specified allegations against Joseph Trambulo to the Discipline Committee of the College. The allegations were referred in accordance with paragraph 26(1)1 of the *Health Professions Procedural Code*. The statement of allegations is attached to this notice of hearing. A discipline panel will hold a hearing under the authority of sections 38 to 56 of the *Health Professions Procedural Code*, as amended, for the purposes of deciding whether the allegations are true. A **pre-hearing conference** may be held by electronic means or at the offices of the College of Physiotherapists of Ontario at 375 University Avenue, Suite 800, Toronto, Ontario, at a date and time to be fixed by the Registrar. A discipline panel will subsequently convene by electronic means or at the offices of the College of Physiotherapists of Ontario at 375 University Avenue, Suite 800, Toronto, Ontario, on a date and time to be fixed by the Registrar but no later than April 1, 2020 for the purposes of conducting the hearing.

IF YOU DO NOT ATTEND AT THE HEARING IN ACCORDANCE WITH THE PRECEDING PARAGRAPH, THE DISCIPLINE PANEL MAY PROCEED IN YOUR ABSENCE AND YOU WILL NOT BE ENTITLED TO ANY FURTHER NOTICE IN

THE PROCEEDINGS.

If the discipline panel finds that you have engaged in professional misconduct,

it may make one or more of the following orders:

1. Direct the Registrar to revoke the registrant's certificate of registration.

2. Direct the Registrar to suspend the registrant's certificate of registration for a

specified period of time.

3. Direct the Registrar to impose specified terms, conditions and limitations on

the registrant's certificate of registration for a specified or indefinite period of

time.

4. Require the registrant to appear before the panel to be reprimanded.

5. Require the registrant to pay a fine of not more than \$35,000 to the Minister

of Finance.

The discipline panel may, in an appropriate case, make an order requiring you

to pay all or part of the College's costs and expenses pursuant to section 53.1 of the

Health Professions Procedural Code.

You are entitled to disclosure of the evidence against you in accordance with

section 42(1) of the Health Professions Procedural Code, as amended. You, or your

# **Statement of Allegations**

- At all material times Josesph Trambulo was a registrant of the College of Physiotherapists of Ontario holding an Independent Practice certificate of registration.
- 2. In the period of December 14, 2020 to March 8, 2021, Joseph Trambulo engaged in professional misconduct within the meaning of the following paragraphs of section 1 of the *Professional Misconduct Regulation*, O. Reg. 388/08:
  - a. paragraph 1 (failing to maintain the standards of practice of the profession);
  - paragraph 18 (engaging in conduct or performing an act relevant to the practice of the profession that, having regard to all the circumstances, would reasonably be regarded by members as disgraceful, dishonourable or unprofessional); and
  - c. paragraph 26 (failing to maintain records in accordance with the standards of practice of the profession).

## **PARTICULARS OF THE ALLEGATIONS**

- 1. At all material times Joseph Trambulo was a physiotherapist registered with the College of Physiotherapists of Ontario (the "College") and the owner of a physiotherapy clinic, PR Health, Health and Therapy Solutions, that operated out of two gyms in the Greater Toronto Area.
- 2. In the period of December 14, 2020 to March 8, 2021, Patient A attended for a physiotherapy assessment and approximately six physiotherapy treatments with Joseph Trambulo. Patient A's presenting conditions related to knee, shoulder and ankle pain.
- 3. In the treatment sessions, Joseph Trambulo engaged in touching that failed to respect Patient A's personal boundaries, fell below the standards of practice of the profession with respect to physiotherapists maintaining professional boundaries, and was undertaken without Patient A's informed consent.
- 4. Joseph Trambulo's record keeping failed to maintain the standards of practice of the profession, including that the clinical chart for Patient A lacked objective measures and outcomes, and failed to provide any or an adequate rationale or justification for the treatment provided.
- 5. Joseph Trambulo failed to maintain the standards of practice of the profession with respect to physiotherapists maintaining professional boundaries in social media communications with patients.
